1. Introduction

The ClariVue[™]20 is a submersible turbidity sensor that uses side-scatter technology to measure suspended solids and turbidity for applications ranging from water quality in aquatic ecosystems to sediment transport and dredge monitoring.



2. Precautions

- READ AND UNDERSTAND the Safety section at the back of this manual.
- The sensor may be damaged if it is encased in ice. Damages caused by freezing conditions
 will not be covered by the warranty.
- Campbell Scientific recommends removing the sensor from the water for the time period that the water is likely to freeze.
- ClariVue 20 is a precision instrument that must be handled with care.
- IMPORTANT: Maintain a level of calibration appropriate to the application. Campbell Scientific recommends factory recalibration of the ClariVue 20 every two years or when it varies by more than 5% in standard buffer within the 0 to 4000 TU range (see Verification procedure [p. 24]).

3. Initial inspection

 Upon receipt of the ClariVue 20, inspect the packaging for any signs of shipping damage, and, if found, report the damage to the carrier in accordance with policy. The contents of the package should also be inspected and a claim filed if any shipping-related damage is discovered.

- When opening the package, take care to not damage or cut the cable jacket. If there is any question about damage having been caused to the cable jacket, a thorough inspection is prudent.
- The model number is on the housing. Check this information against the shipping documentation to ensure that the expected model number was received.


4. QuickStart

Short Cut is an easy way to program your data logger to measure the sensor and assign data logger wiring terminals. *Short Cut* is available as a download on www.campbellsci.com . It is included in installations of *LoggerNet*, *RTDAQ*, and *PC400*.


The following procedure also shows using **Short Cut** to program the ClariVue 20.

- 1. Open *Short Cut* and click **Create New Program**.
- 2. Double-click the data logger model.

3. In the Available Sensors and Devices box, type ClariVue or find the sensor in the Sensors > Water > Quality folder, and double-click ClariVUE10/ClariVUE20. SDI-12 Address defaults to 0. Enter the correct SDI-12 Address for the sensor if it has been changed from the factory default value. Mean temperature defaults to degrees Celsius. These can be changed by clicking the Mean temperature box and selecting a different option.




4. Click the Wiring tab. Click OK after wiring the sensor.



5. Repeat steps three and four for other sensors being measured. Click **Next**.


6. In Output Setup, type the scan rate, a Table Name, and Data Output Storage Interval. Click Next.



NOTE:

Because of the sensor response time, Campbell Scientific recommends measurement scans of at least 30 seconds.

7. Select the output options.



8. Click **Finish** and save the program. Send the program to the data logger if the data logger is connected to the computer.

9. If the sensor is connected to the data logger, check the output of the sensor in the data display in *LoggerNet*, *RTDAQ*, or *PC400* to make sure it is making reasonable measurements.

Overview

The heart of the ClariVue 20 is a near-infrared (NIR) laser and a photodiode for detecting the intensity of light scattered from suspended particles in water. The detector is positioned at 90 degrees to the emitter to measure the side-scatter energy. The ClariVue 20 has two measurement ranges. The low range is from 0-400 TU and uses a transfer function to convert mV readings to turbidity units based on 4 calibration points in this range: 0, 20, 100, and 400 TU. The high range is from 401 to 4000 TU. The high range transfer function converts millivolt to turbidity units using seven calibration points across the full measurement range: 0, 20, 100, 400, 1000, 2500, and 4000 TU.

Turbidity sensors are used for a wide variety of monitoring tasks in riverine, oceanic, laboratory, and industrial settings. They can be integrated with water-quality monitoring systems, conductivity, temperature, and depth sensors (CTDs), laboratory instrumentation, and sediment-transport monitors.

- Compliance with permits, water-quality guidelines, and regulations
- Determination of transport and fate of particles and associated contaminants in aquatic systems
- Conservation, protection, and restoration of surface waters
- Assessing the effects of land-use management on water quality

7. Installation

If you are programming your data logger with **Short Cut**, skip Wiring (p. 7) and Programming (p. 10). Short Cut does this work for you. See QuickStart (p. 2) for a tutorial.

7.1.1 SDI-12 wiring

Table 7-1 (p. 8) provides data logger connections when using SDI-12. Connect the wires in the order shown in the table.

If multiple SDI-12 sensors are connected to a data logger, Campbell Scientific recommends using separate terminals when possible. However, multiple SDI-12 sensors can connect to the same data logger control (**C**) or universal (**U**) terminal. Each must have a unique SDI-12 address. Valid addresses are 0 through 9, a through z, and A through Z.

For CR6 and CR1000X data loggers using SDI-12, triggering conflicts may occur when a companion terminal is used for a triggering instruction such as TimerInput(), PulseCount(), or WaitDigTrig(). For example, if this product is connected to C3 on a CR1000X, C4 cannot be used in the TimerInput(), PulseCount(), or WaitDigTrig() instructions.

7.1.2 Modbus wiring

Table 7-2 (p. 9) provides data logger connections when using Modbus. Connect the wires in the order shown in the table.

The RS-485 output can be directly read by a CR6-series, CR1000X-series, CR350-series, or Modbus RTU RS-485 network. Other Campbell Scientific data loggers can use an MD485 multidrop interface to read the RS-485 output. Refer to the MD485 manual for information about using the MD485.

7.1.3 Analog wiring

Table 7-3 (p. 9) provides data logger connections when using an analog output. Connect the wires in the order shown in the table.

The analog output can be read by all our data loggers. To enable the analog out, the white wire must be supplied with +5Vdc. This allows the analog out to only be powered up when needed

7.2 Programming

Short Cut is the best source for up-to-date programming code for Campbell Scientific data loggers. If your data acquisition requirements are simple, you can probably create and maintain a data logger program exclusively with **Short Cut**. If your data acquisition needs are more complex, the files that **Short Cut** creates are a great source for programming code to start a new program or add to an existing custom program.

NOTE:

Short Cut cannot edit programs after they are imported and edited in CRBasic Editor.

A *Short Cut* tutorial is available in QuickStart (p. 2). If you wish to import *Short Cut* code into *CRBasic Editor* to create or add to a customized program, follow the procedure in Importing Short Cut code into CRBasic Editor (p. 32). Programming basics for CRBasic data loggers are provided in the following sections. Downloadable example programs are available at www.campbellsci.com/downloads/clarivue20-example-programs.

7.2.1 SDI-12 programming

The SDI12Recorder() instruction is used to measure a ClariVue 20 configured for SDI-12 measurements. The SDI12Recorder() instruction sends a request to the sensor to make a measurement and then retrieves the measurement from the sensor. See SDI-12 measurements (p. 15) for more information.

For most data loggers, the SDI12Recorder() instruction has the following syntax:

SDI12Recorder(Destination, SDIPort, SDIAddress, "SDICommand", Multiplier, Offset,
FillNAN, WaitonTimeout)

Valid values for the **SDIAddress** are 0 through 9, a through z, and A through Z; alphabetical characters need to be enclosed in quotation marks (for example, "A"). Also enclose the **SDICommand** in quotation marks as shown. The **Destination** parameter must be an array. The required number of values in the array depends on the command; see .

FillNAN and **WaitonTimeout** are optional parameters (refer to *CRBasic Editor* help for more information).

7.2.2 Modbus programming

The RS-485 output can be directly read by a CR6-series, CR1000X-series, CR350-series, or Modbus RTU RS-485 network. Other Campbell Scientific data loggers can use an MD485 multidrop interface to read the RS-485 output. Refer to the MD485 manual for information about using the MD485.

A CR6, CR1000X, or CR350-series data logger programmed as a Modbus client can retrieve the values stored in the input registers (Modbus measurements [p. 19]). To do this, the CRBasic program requires the SerialOpen() instruction followed by ModbusClient() instruction.

NOTE:

ModbusClient() was formerly ModbusMaster(). Campbell Scientific, in conjunction with the Modbus Organization, is now using "client-server" to describe Modbus communications. The Modbus client(s) initiates communications and makes requests of server device(s). Server devices process requests and return an appropriate response (or error message). See https://modbus.org for more information. Existing programs that use the old Modbus terminology will still compile in the data logger.

The **SerialOpen** instruction has the following syntax:

```
SerialOpen (ComPort, Baud, Format, TXDelay, BufferSize, Mode)
```

Use 9600 for the **Baud** parameter. The **Format** parameter is typically set to logic 1 low; even parity, one stop bit, 8 data bits. The **Mode** parameter should configure the ComPort as RS-485 half-duplex, transparent.

The ModbusClient() instruction has the following syntax:

```
ModbusClient (Result, ComPort, Baud, Addr, Function, Variable, Start, Length,
Tries, TimeOut, [ModbusOption])
```

The **Addr** parameter must match the sensor Modbus address. Use 9600 for the **Baud** parameter. To collect all of the values, the **Start** parameter needs to be 1 and the **Length** parameter needs to correspond with the register count (see Modbus measurements [p. 19]).

7.2.3 Analog programming

For the analog output option, the ClariVue 20 has a digital-to-analog converter (DAC) that outputs 0 to 1 VDC for the full range of 0 to 4000 NTU. Because the analog output requires the sensor to continuously measure turbidity and also power the DAC, the sensor will not go to a low power state while in this mode. Subsequently, the current draw is significantly higher with analog

out than with the digital protocols. To enable the analog out, the white wire must be supplied with +5 VDC. This allows the analog out to only be powered up when needed.

The voltage output is measured using the **VoltDiff()** CRBasic instruction, then the voltage measurement is converted to NTU. The **VoltDiff()** has the following format:

```
VoltDiff (Dest, Reps, Range, DiffChan, RevDiff, SettlingTime, fN1, Multiplier,
Offset)
```

The following are example CRBasic instructions for measuring the voltage measurement and converting that voltage measurement to NTU:

```
VoltDiff (CV20_mV,1,mV5000,1,True,0,60,1.0,0)
'Convert the voltage measurement to NTU
CV20_NTU = CV20_mV * 4
```


Where CV20_mV is the millivolt measurement from the sensor and CV20_NTU is the converted NTU value.

7.3 Mounting

Schemes for mounting the ClariVue 20 will vary with applications; however, the same basic precautions should be followed to ensure the unit is able to make a good measurement and that it is not lost or damaged.

- Orient the unit so that the ClariVue 20 looks into clear water without reflective surfaces. This includes any object such as a mounting structure, a stream bed, or sidewalls. The sidescatter sensor can see to about 5 cm (2 in) at 90°.
- Campbell Scientific recommends avoiding direct sunlight. The ClariVue 20 measures any
 infrared light source pulsing at a 5 kHz rate that is in sync with the 5 kHz internal verticalcavity surface-emitting laser (VCSEL) light driver. Therefore, the combination of direct
 sunlight and a rippling water surface can affect turbidity measurements. Some installations
 may require shading to prevent sunlight interference.


• Always place electrical tape or 2 mm (1/16 in) neoprene sheet on the housing where the housing will contact metal or other hard objects.




• The most convenient means for mounting the unit to a frame or wire is to use large, highstrength nylon cable ties (7.6 mm (0.3 in) width) or stainless steel hose clamps. First cover the area(s) to be clamped with electrical tape or 2 mm (1/16 in) neoprene sheet. Clamp the unit to the mounting frame or wire in the padded area.

CAUTION:

Lightly tighten the hose clamps. Overtightening may crack the pressure housing and cause a leak. Use spacer blocks when necessary to prevent chafing the unit with the frame or the wire.



• Mounting inside the end of a PVC pipe is a convenient way to provide structure and protection for deployments. The ClariVue 20 fits inside a 2-in schedule 40 PVC pipe.

8.1 Turbidity units

Conceptually, turbidity is a numerical expression in turbidity units (TU) of the optical properties that cause water to appear hazy or cloudy as a result of light scattering and absorption by suspended matter. Operationally, a TU value is interpolated from neighboring light-scattering measurements made on calibration standards such as Formazin, StablCal®, or styrene divinylbenzene (SDVB) beads. Turbidity is caused by suspended and dissolved matter such as

sediment, plankton, bacteria, viruses, and organic and inorganic dyes. In general, as the concentration of suspended matter in water increases, so will its turbidity; as the concentration of dissolved, light-absorbing matter increases, turbidity will increase.

Descriptions of the factors that affect turbidity are given in Factors that affect turbidity and suspended-sediment measurements (p. 33). Like all other optical turbidity monitors, the response depends on the size, the composition, and the shape of suspended particles. For this reason, for monitoring concentrations, the sensor must be calibrated with suspended sediments from the waters to be monitored. There is no standard turbidimeter design or universal formula for converting TU values to physical units such as mg/l or ppm. TU values have no intrinsic physical, chemical, or biological significance. However, empirical correlations between turbidity and environmental conditions, established through field calibration, can be useful in water-quality investigations.

The USGS has an excellent chapter on turbidity measurements in their *National Field Manual for the Collection of Water-Quality Data*:

Historically, most turbidity sensor manufacturers and sensor users labeled the units NTUs, for Nephelometric Turbidity Units. The ASTM and the USGS unit classification for side scatter is formazin nephelometric unit (FNU)

8.2 SDI-12 measurements

The ClariVue 20 responds to the SDI-12 commands shown in Table 8-1 (p. 16). When the data logger issues an M! command, the sensor should respond immediately indicating how long it will take to perform the measurement. The data logger then waits that amount of time or if the sensor finishes sooner, it will send a service request to the data logger indicating data can be collected. After receiving the service request or waiting the indicated time, the data logger will send the D! command to collect the data.

NOTE:

SDI-12 sensor support (p. 35) describes the SDI-12 commands. Additional SDI-12 information is available at www.sdi-12.org \square .

8.2.2 Updating the operation system (OS) using XLOADOS SDI-12 command

The SDI-12 extended command XLOADOS! sends the new operating system (OS) to the sensor.

NOTE:

Only the CR6, CR1000X, and CR300-series data loggers are compatible with the **XL0ADOS!** functionality.

Verify that the data logger has been updated to the latest OS to ensure compatibility.

If a compatible data logger is not available to update the sensor, send the sensor to the factory to have Campbell Scientific update the OS. A returned material authorization (RMA) and completion of the "Statement of Product Cleanliness and Decontamination" form are required. Refer to the page near the end of this manual for more information.

The data loggers need the following OS versions:

CR6: OS 11 or newer

CR1000X: OS 5.0 or newer

• CR300 series: OS 10.05 or newer

The **XLOADOS**! OS update process requires access to the data logger terminal. Campbell Scientific *Device Configuration Utility* is recommended.

Although this update may be performed remotely, if the sensor is not communicating with the data logger, it must first be power cycled to regain communication and accept the new OS.

- 1. Download the update file from the Campbell Scientific website and run the self-extracting executable. The extraction takes only a moment, and a dialog box will indicate that the OS file has been saved on the computer in the C:\Campbellsci\Lib\OperatingSystems directory.
- 2. Upload the OS to the data logger CPU drive using Device Configuration Utility.
 - a. Connect to the data logger.
 - b. Open the File Control tab.
 - c. Click **Send** and select the OS file from the **C:\Campbellsci\Lib\OperatingSystems** directory. File type may need to be changed to **All Files (*.*)** for the OS file to show up on the list.



d. Verify that the file is now on the data logger CPU drive.

- 3. Connect the sensor to the data logger digital and power terminals. Note the terminal to which the sensor is connected.
- 4. Open a terminal interface to the data logger. Press Enter twice within the terminal window to get a command prompt.



- 5. Within the terminal, run the following commands:
 - a. Type **SDI12** at the prompt and then enter the corresponding number assigned to the digital terminal to which the sensor is connected.
 - b. Identify the SDI-12 address of the sensor by typing?! at the prompt.
 - c. Verify that the responding sensor is the ClariVue 20 that you want to update by using the SDI-12 verify command aI!.
- 6. Send the OS to the sensor with the XLOADOS! extended command in the following format:

<SDI-12 address>XLOADOS <baud rate> CPU:<OS name>!

NOTE:

A baud rate of 9600 is typically used. CR300-series data loggers are case sensitive, and the file name must match the name used in the command. The **All Caps** checkbox on the bottom will need to be unchecked to allow lowercase letters.

7. When the OS update is complete, the file size, bytes sent, and the word **SUCCESS** are displayed. For example:

file size 117500, bytes sent 117304SUCCESS

8. Verify that the OS was updated with the verify command **aV!**, followed by the **aD0!** command to read the results.

8.3 Modbus measurements

CAUTION:

If communication with the sensor is delayed two minutes or longer, the sensor will enter low-power mode. To obtain an accurate reading after the sensor enters low-power mode, first send a command to wake the sensor. Then, wait for the duration of the Measurement Type power-up interval before requesting a new reading.

When using Modbus communication with the ClariVue 20 sensor, consider both the required power-up time for obtaining accurate readings and the timing of the sensor transition into low-power mode. See Table 8-4 (p. 21) for a description of the three measurement types.

Power-up time required to get a good reading:

• Measurement Type 1: 24 seconds

• Measurement Type 2: 40 seconds

• Measurement Type 3: 32 seconds

Low-Power Mode Behavior:

The time before entering a low-power state after the last received communication is as follows:

• Measurement type 1: 120 seconds or 2 minutes

• Measurement type 2: 300 seconds or 5 minutes

• Measurement type 3: 300 seconds or 5 minutes

If the communication interval exceeds this time, the ClariVue 20 will enter low-power mode after saving its last measurement. When a new Modbus packet/poll is received after the sensor is in the low-power mode, the sensor will initially provide the last saved reading rather than the current measurement. New values will not be available for up to 24 s (measurement type 1), 40 s (measurement type 2), or 32 s (measurement type 3).

Table 8-3 (p. 20) provides the input register map (function code 4) and Table 8-4 (p. 21) provides the holding register map (functions 3 and 6; function 16 is not available). See Modbus programming (p. 11) for details on programming a data logger for Modbus communications.

8.4 Vertical-cavity surface-emitting laser diode




Figure 8-1. Sidescatter detectors

The ClariVue 20 sensor detects suspended matter in water and turbidity from the relative intensity of light, side scattered at 90° in accordance with ISO7027. A 3D image of the main components of the sensor is shown in Figure 8-1 (p. 22). The ClariVue 20 light source is a vertical-cavity surface-emitting laser diode (VCSEL), which converts 7 mA of electrical current to 1500 μ W of optical power. The detector is a low-drift silicon photodiode with enhanced NIR responsivity. NIR responsivity is the ratio of electrical current produced per unit of light power in air or water. A light baffle prevents direct illumination of the detector by the light source and in-phase coupling that would otherwise produce large signal biases. The silicon photodiode features a daylight

blocking filter matched with 830 nm to 950 nm infrared emitters. The daylight blocking filter protects the photodiode from ambient light saturation.

9. Maintenance, troubleshooting, and verification procedure

NOTE:

All factory repairs and recalibrations require a returned material authorization (RMA) and completion of the "Statement of Product Cleanliness and Decontamination" form. Refer to the Assistance page for more information.

9.1 Maintenance

CAUTION:

No user-serviceable parts are inside the sensor housing. Do not remove the sensor or connector from the pressure housing. This will void the warranty and could cause a leak.

Periodically clean the ClariVue 20 window:

- 1. If encrusted organisms such as barnacles or tube worms are on the ClariVue 20 window, use a flexible knife blade to gently scrape them off.
- 2. For other types of fouling, wet a scouring pad.
 - a. Place the scouring pad on a counter with a plastic-laminate top with the pad side aligned with the edge of the counter.
 - b. Rub the sensor window back and forth on the pad until it is clean.

Do the following to remove pits from the sensor face:

- 1. Tape a strip of 400 grit wet-or-dry abrasive cloth to the edge of a counter.
- 2. Add a few drops of water to the abrasive cloth.
- 3. Using the counter edge as a guide, rub the sensor window on the cloth in smooth one-way strokes until the sensor is shiny and pit free.

WARNING:

Do not use solvents such as methyl ethyl ketone (MEK), toluene, acetone, or trichloroethylene on the ClariVue 20.

Verify sensor calibration (Verification procedure [p. 24]) when visiting site to clean the sensor. If sensors deviate more than 5% send to Campbell Scientific for factory calibration (refer to for more information).

9.2 Troubleshooting

- 1. Check the wiring to ensure the ClariVue 20 wires are connected to the correct data logger terminals (see Wiring [p. 7]).
- 2. Check the data logger program scan rate is sufficient for the SDI-12 commands (SDI-12 measurements [p. 15]).
- 3. Check the data logger program to ensure that the SDI-12 address matches the ClariVue 20 SDI-12 address and that the **SDIPort** matches the data logger connections.

9.3 Verification procedure

Campbell Scientific recommends checking the calibration in the field. This section explains how to verify the factory calibration is still within 5% or a user set threshold.

Supplies:

- Data logger
- ClariVue 20 cable
- ClariVue 20
- Computer with Device Configuration Utility installed
- Formazin or StableCal Turbidity standards of your choice between 0 to 4000 TU.
- Deionized (DI) water for rinsing sensor and 0.4 TU point for checking
- 8 liter (2 gallon) black plastic bucket if you are using DI water as one of your check points.
- 100 mm (4 in) diameter, black calibration cup for standards less than 20 TU
- Isopropyl alcohol or denatured alcohol
- Microfiber cloth

Procedure:

- 1. Swab sensor with an alcohol-soaked towel to sterilize it.
- 2. Wire sensor to the data logger. Many data loggers offer a terminal mode to talk to SDI-12 sensors. This procedure requires an SDI-12 recorder/data logger that can return multiple lines for an extended SDI-12 command. For this example, the ClariVue 20 is connected to the following terminals on a Campbell Scientific CR1000X data logger.



NOTE:

To verify the calibration, you do not need to have a program running on the data logger.

3. Open *Device Configuration Utility*.

- 4. Under **Device Type**, type the data logger model and double-click on the model type. This example uses a CR1000X directly connected to the computer USB port.
- 5. Select the correct **Communication Port** and click **Connect**.




6. Click the **Terminal** tab.



NOTE:

To save the 25 verification readings in a text editor, click **Start Export** that is at the bottom of the screen. This log can be easily transferred to a spreadsheet. Select **All Caps** to simplify entering the SDI-12 commands.



7. Press Enter until the data logger responds with the data logger (CR1000X>) prompt.



- 8. Type SDI12 and press Enter.
- At the Select SDI12 Port prompt, type the number corresponding to the control port where
 the sensor is connected and press Enter. In this example the sensor is connected to C3. The
 response Entering SDI12 Terminal indicates that the sensor is ready to accept SDI-12
 commands.

10. Type ?! to determine the address of your sensor. The default sensor address is 0.

?!

NOTE:

If the standards are cold or the sensor was recently removed from the water, the ClariVue 20 will need to equilibrate to the ambient temperature before doing the next step.

11. Submerge the ClariVue 20 into the first calibration standard or DI water. Place the sensor vertically, in the middle of the calibration cup. If the first point is DI water or a turbidity standard less than 20 TU, use a black 8 liter (2 gallon) bucket, preferably tumbled so the inside of the bucket is not glossy/reflective.

12. Type aXTEST!, where a is the sensor address (0 in this example). This SDI-12 command collects 25 measurements, which is similar to running the M! command 25 times in rapid succession.

13. If the values are stable, remove the sensor from standard 1. If you have it in DI water, cover the DI water bucket and go to the next step. If the calibration standard is greater than 0 TU, rinse the sensor with DI water to reduce contamination of standards. Dry the sensor to reduce dilution of the next standard. Pour the calibration standard into the bottle and cap it, or cover the bucket to reduce evaporation and cross contamination.

14. Place the sensor in your second standard. If the turbidity value is greater than 20 TU, use a smaller calibration cup, preferably a black plastic container with a diameter less than 4 inches.

NOTE:

The second standard should be within the range of the field site conditions or the range of turbidity in which you are most interested. For high turbidity waters, check at 1000 and 4000 TU. For less turbid bodies of water, check the 0 point and 250 TU.

In the following example, the turbidity standard is approximately 765 TU.

- 15. End the **Export** of the data.
- 16. Open the text file in Excel to export the data for your records. The terminal data exported from the *Device Configuration* utility is a space-delimited file. The following shows the text file imported into Excel and post-processed.

Appendix A. Importing Short Cut code into CRBasic Editor

Short Cut creates a .DEF file that contains wiring information and a program file that can be imported into **CRBasic Editor**. By default, these files reside in the C:\campbellsci\SCWin folder.

Import *Short Cut* program file and wiring information into *CRBasic Editor*:

 Create the Short Cut program, then save it. Click the Advanced tab then the CRBasic Editor button. Your program file will open in CRBasic with a generic name. Provide a meaningful name and save the CRBasic program. This program can now be edited for additional refinement.

NOTE:

Once the file is edited with *CRBasic Editor*, *Short Cut* can no longer be used to edit the program.

- 2. To add the *Short Cut* wiring information into the new CRBasic program, open the .DEF file located in the C:\campbellsci\SCWin folder. Copy the wiring information found at the beginning of the .DEF file.
- 3. Go into the CRBasic program and paste the wiring information at the beginning of the program.
- 4. In the CRBasic program, highlight the wiring information, right-click, and select **Comment Block**. This adds an apostrophe (') to the beginning of each of the highlighted lines, which instructs the data logger compiler to ignore those lines when compiling. The **Comment Block** feature is demonstrated at about 5:10 in the CRBasic | Features video .

Appendix B. Factors that affect turbidity and suspended-sediment measurements

This appendix summarizes some of the factors that affect turbidity measurements and shows how ignoring them can lead to erroneous data. If you are certain that the characteristics of suspended matter will not change during your survey and that your sensor was factory-calibrated with sediment from your survey site, you only need to skim this section to confirm that no problems have been overlooked.

B.1 Particle size

The size of suspended-sediment particles typically ranges from about 0.2 to 500 μ m in surface water (streams, estuaries, and ocean). With size, shape, and color remaining constant, particle area normal to a light beam will determine the intensity of light scattered by a volume of suspended matter.

B.2 Suspensions with mud and sand

Light scattering from particles is inversely related to particle size on a mass concentration basis. This can lead to serious difficulties in flow regimes where particle size varies with time. For example, when sandy mud goes through a cycle of suspension and deposition during a storm, the ratio of sand to mud in suspension will change. A turbidity sensor calibrated for a fixed ratio of sand to mud will, therefore, indicate the correct concentration only part of the time. There are no simple remedies for this problem. One solution is to take many water samples and analyze them in the laboratory; however, this is not always practical during storms when the errors are likely to be largest. Do not rely solely on turbidity sensors to monitor suspended-sediment particles when particle size or composition is expected to change with time at a monitoring site.

B.3 Particle-shape effects

In addition to size and flocculation/aggregation, particle shape has a significant effect on the scattering intensity from a sample and calibration slope of a turbidity sensor. Plate-shaped particle (clay-mineral particles, for example) backscatter light about ten times more efficiently

than spherical particles, while angular shapes have intermediate scattering efficiency. Turbidity sensors are very sensitive to shape effects and this makes it very important to calibrate with material from the monitoring site. It is also essential that particle shape remains constant during the monitoring period.

B.4 High-sediment concentrations

At high sediment concentrations, particularly in suspensions of clay and silt, the infrared radiation from the emitter can be so strongly attenuated along the path connecting the emitter, the particle, and the detector, that backscatter decreases exponentially with increasing sediment concentration. For mud, this occurs at concentrations greater than about 5,000 mg/l. Do not exceed the specified turbidity or suspended-sediment ranges because the interpretation of the signal can be ambiguous.

B.5 Water color

Although organic and inorganic infrared-absorbing, dissolved matter has visible color, its effect on turbidity measurements is small unless the colored compounds are strongly absorbing at the sensor wavelength (850 nm) and are present in high concentrations. Only effluents from minetailings produce enough color to absorb measurable infrared. In river, estuary, and ocean environments, concentrations of colored materials are too low by at least a factor of ten to produce significant errors.

Appendix C. SDI-12 sensor support

Serial Data Interface at 1200 baud (SDI-12) is a protocol developed to simplify sensor and data logger compatibility. Only three wires are necessary—serial data, ground, and 12 V. With unique addresses, multiple SDI-12 sensors can connect to a single SDI-12 terminal on a Campbell Scientific data logger.

This appendix discusses the structure of SDI-12 commands and the process of querying SDI-12 sensors. For more detailed information, refer to version 1.4 (January 2019) of the SDI-12 protocol, available at www.sdi-12.org \Box .

C.1 SDI-12 command basics

SDI-12 commands have three components:

- Sensor address (a) a single character and the first character of the command. Use the default address of zero (0) unless multiple sensors are connected to the same port.
- Command body an upper case letter (the "command"), optionally followed by one or more alphanumeric qualifiers.
- Command termination (!) an exclamation mark.

An active sensor responds to each command. Responses have several standard forms and always terminate with <CR><LF> (carriage return and line feed). Standard SDI-12 commands are listed in Table C-1 (p. 35).

C.1.1 Acknowledge active command (a!)

The acknowledge active command (a!) is used to test a sensor on the SDI-12 bus. An active sensor responds with its address.

C.1.2 Send identification command (al!)

Sensor identifiers are requested by issuing command aI!. The reply is defined by the sensor manufacturer but usually includes the sensor address, SDI-12 version, manufacturer's name, and sensor model information. Serial number or other sensor specific information may also be included. Source: SDI-12: A Serial-Digital Interface Standard for Microprocessor-Based Sensors (see References [p. 44]).

C.1.3 Start verification command (aV!)

The response to start verification (aV!) can include hardware diagnostics, but like the aI! command, the response is not standardized.

Command: aV!

Response: atttn < CR > < LF >

a = sensor address

ttt = time, in seconds, until verification information is available

n = the number of values to be returned when one or more subsequent D! commands are issued

 $\langle CR \rangle \langle LF \rangle$ = terminates the response

C.1.4 Address query command (?!)

Command?! requests an address of the connected sensor. The sensor responds to the query with the address, a. This command should only be used with one sensor on the SDI-12 bus at a time.

C.1.5 Change address command (aAb!)

Multiple SDI-12 sensors can connect to a single SDI-12 terminal on a data logger. Each device on a single terminal must have a unique address.

A sensor address is changed with command aAb!, where a is the current address and b is the new address. For example, to change an address from 0 to 2, the command is 0A2!. The sensor responds with the new address b, which in this case is 2.

NOTE:

Only one sensor should be connected to a particular terminal at a time when changing addresses.

C.1.6 Start measurement commands (aM!)

A measurement is initiated with the M! command. The response to each command has the form atttn < CR > < LF >, where

a = sensor address

ttt = time, in seconds, until measurement data is available; when the data is ready, the sensor notifies the data logger, and the data logger begins issuing **D** commands.

n = the number of values returned when one or more subsequent **D** commands are issued; for the **aM!** command, n is an integer from 0 to 9.

When the **aM!** command is issued, the data logger pauses its operation and waits until either it receives data from the sensor or the time (*ttt*) expires. Depending on the scan interval of the data logger program and the response time of the sensor, this may cause skipped scans to occur. To avoid this, ensure that the scan interval is greater than the longest measurement time (*ttt*).

C.1.7 Start concurrent measurement commands (aC!)

A concurrent measurement (aC!) command follows the same pattern as the aM! command with the exception that it does not require the data logger to pause its operation, and other SDI-12 sensors may take measurements at the same time. The sensor will not issue a service request to notify the data logger that the measurement is complete. The data logger will issue the aD0! command during the next scan after the measurement time reported by the sensor has expired. To use this command, the scan interval should be 10 seconds or less. The response to each command has the form atttn < CR > < LF >, where

a =the sensor address

ttt = time, in seconds, until the measurement data is available

nn = the number of values to be returned when one or more subsequent **D**! commands are issued.

See the following example. A data logger has three sensors wired into terminal C1. The sensors are addresses X, Y, and Z. The data logger will issue the following commands and receive the following responses:

XC!	The data logger makes a request to sensor X to start a concurrent measurement.

YD0!	Ten seconds later, after a total of 40 seconds have passed, the data logger starts the process of collecting data from sensor Y by issuing the first D command.

C.1.8 Start measurement commands with cyclic redundancy check (aMC! and aCC!)

Error checking is done by using measurement commands with cyclic redundancy checks (aMC! or aCC!). This is most commonly implemented when long cable lengths or electronic noise may impact measurement transmission to the data logger. When these commands are used, the data returned in response to D! or R! commands must have a cyclic redundancy check (CRC) code appended to it. The CRC code is a 16-bit value encoded within three characters appended before the <CR> <LF>. This code is not returned in the data table but is instead checked by the data logger as it comes. The code returned is based on the SDI-12 protocol. See the SDI-12 communication specification for version 1.4 version 1.4 (January 2019) available at www.sdi-12.org 17 to learn more about how the CRC code is developed.

C.1.9 Stopping a measurement command

A measurement command (aM!) is stopped if it detects a break signal before the measurement is complete. A break signal is sent by the data logger before most commands.

A concurrent measurement command (aC!) is aborted when another valid command is sent to the sensor before the measurement time has elapsed.

C.1.10 Send data command (aD0! ... aD9!)

The send data command (aD!) requests data from the sensor. It is issued automatically with every type of measurement command (aM!, aMC!, aC!, aCC!). When the measurement command is aM! or aMC!, the data logger issues the aDO! command once a service request has been received from the sensor or the reported time has expired. When the data logger is issuing concurrent commands (aC! or aCC!), the send data command is issued after the required time has elapsed (no service request will be sent by the sensor). In transparent mode (see SDI-12 transparent mode [p. 42]), the user asserts this command to obtain data.

Depending on the type of data returned and the number of values a sensor returns, the data logger may need to issue **aD0**! up to **aD9**! to retrieve all data. A sensor may return up to 35 characters of data in response to an **aD**! command that follows an **aM**! or **aMC**! command. A sensor may return up to 75 characters of data in response to a **aD**! command that follows an **aC**! or **aCC**! command. Data values are separated by plus or minus signs.

Command: aD0! (aD1! ... aD9!)

Response: a<values><CR><LF> or a<values><CRC><CR><LF>
where

a = the sensor address

<values> = values returned with a polarity sign (+ or -)

<CR><LF> = terminates the response

<CRC> = 16-bit CRC code appended if data was requested with aMC! or aCC!.

C.1.11 Continuous measurement command (aR0! ... aR9!)

Sensors that are able to continuously monitor the phenomena to be measured can be read directly with the R! commands (R0! ... R9!). The response to the R! commands mirrors the Send Data command (aD0!). A maximum of 75 characters can be returned in the <values> part of the response to the R! command.

C.1.12 Extended commands

Many sensors support extended SDI-12 commands. An extended command is specific to a make of sensor and tells the sensor to perform a specific task. They have the following structure. Responses vary from unit to unit. See the sensor manual for specifics.

Command: aXNNNN!

The command will start with the sensor address (a), followed by an X, then a set of optional letters, and terminate with an exclamation point.

Response: a < optional values > < CR > < LF >

The response will start with the sensor address and end with a carriage return/line feed.

C.2 SDI-12 transparent mode

System operators can manually interrogate and enter settings in probes using transparent mode. Transparent mode is useful in troubleshooting SDI-12 systems because it allows direct communication with probes. Data logger security may need to be unlocked before activating the transparent mode.

Transparent mode is entered while the computer is communicating with the data logger through a terminal emulator program. It is accessed through Campbell Scientific data logger support software or other terminal emulator programs. Data logger keyboards and displays cannot be used.

The terminal emulator is accessed through Campbell Scientific *Device Configuration Utility* software.

Data loggers from other manufacturers will also have a transparent mode. Refer to those manuals on how to use their transparent mode.


The following examples show how to enter transparent mode and change the SDI-12 address of an SDI-12 sensor. The steps shown in Changing an SDI-12 address (p. 42) are used with most Campbell Scientific data loggers.

C.2.1 Changing an SDI-12 address


This example was done with a CR1000X, but the steps are only slightly different for Granite-series, CR6, CR800-series, CR300-series data loggers.

- 1. Connect an SDI-12 sensor to the CR1000X.
- 2. Open Device Configuration Utility.
- 3. Under **Device Type**, type the data logger model and double-click on the model type. This example uses a CR1000X directly connected to the computer USB port.


4. Select the correct Communication Port and click Connect.



5. Click the **Terminal** tab.



Select All Caps Mode.



7. Press **Enter** until the data logger responds with the data logger (**CR1000X>**) prompt.



- 8. Type SDI12 and press Enter.
- At the Select SDI12 Port prompt, type the number corresponding to the control port where the sensor is connected and press Enter. In this example the sensor is connected to C3. The

response **Entering SDI12 Terminal** indicates that the sensor is ready to accept SDI-12 commands.

10. To query the sensor for its current SDI-12 address, type **?!** and press **Enter**. The sensor responds with its SDI-12 address. If no characters are typed within 60 seconds, the mode is exited. In that case, simply type **SDI12** again, press **Enter**, and type the correct control port number when prompted.

?!

11. To change the SDI-12 address, type **aAb!**, where **a** is the current address from the previous step and **b** is the new address. Press **Enter**. The sensor changes its address and responds with the new address. In the following example, the sensor address is changed from 0 to B.

12. To exit SDI-12 transparent mode, click **Close Terminal**.

NOTE:

The transparent mode for the Granite-series, CR6, CR3000, CR800-series, CR300-series data loggers is similar to that shown for the CR1000X.

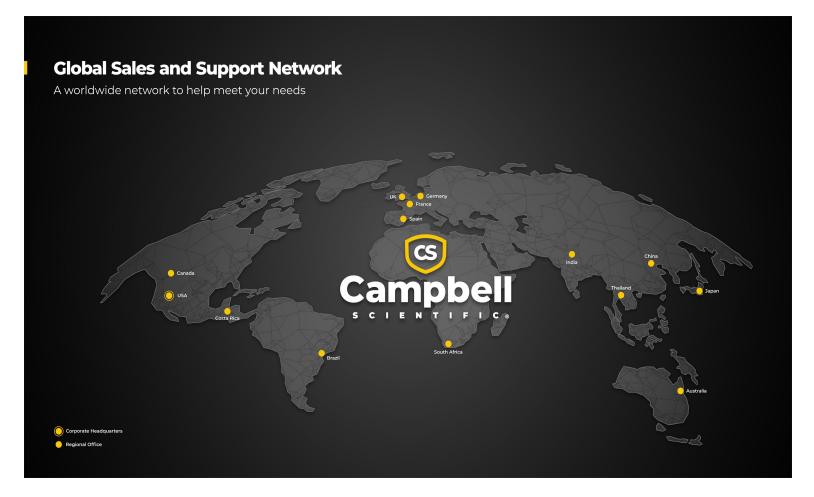
Avoiding unnecessary exposure to radio transmitter radiation
